



Visa Requirement

Business Visa Requirement:

- Visa application form B62.3 fully completed and signed
- Passport size photograph (35 x 45mm or 1.38" x 1.77")
- Proof of Residency or Permanent Resident Card – for non-US citizens
- Passport be valid at least six months beyond the dates of your trip
- Letter stating purpose and duration of your trip
- Proof of sufficient funds to cover all expenses
- Fee
 - Single \$70 USD
 - 3 Months \$100 USD
 - 6 Months \$200 USD
 - 1 Year \$300 USD
- Money Orders, Company and Cashier's Checks payable to 'EMBASSY OF ERITREA'. Cash payments are not acceptable.
- All fees are non-refundable
- Minimum of 10 days are required for processing
- Applicants sending application by mail must provide self-addressed return envelope with tracking number (Express Mail, Priority Mail, FedEx, UPS or DHL)

Employment Visa Requirement:

- Visa application form B62.3 fully completed and signed
- Passport Photo (35 x 45mm or 1.38" x 1.77")
- Proof of residency or Permanent Resident Card – for non-US citizens
- Passport be valid at least six months beyond the dates of your trip
- A letter of employment from sponsoring entity stating your role and duration of your employment
- Fee is \$70 USD
- Money Order, Company and Cashier's Checks payable to 'EMBASSY OF ERITREA'. Cash payments are not acceptable.
- All fees are non-refundable
- Minimum of 10 days are required for processing
- Applicants sending application by mail must provide self-addressed return envelope with tracking number (Express Mail, Priority Mail, FedEx, UPS or DHL)
- Application can be submitted at the Embassy Monday – Thursday 9:00am – 2:00pm

Family Visit Visa Requirement:

- Visa application form B62.3 fully completed and signed
- Passport size photograph

- Proof of residency permit (Green Card) – for non-US citizens
- Passport be valid at least six months beyond the dates of your trip
- Proof of sufficient funds to cover all expenses
- Reference in Eritrea. Your reference needs to be a resident in Eritrea and able to go to Asmara Immigration to follow up on your visa request.
- Fee \$50 USD
- Money Order, Company and Cashier's Checks payable to 'EMBASSY OF ERITREA'. Cash payments are not acceptable.

Only cashier's checks and money orders are acceptable and should be made payable to 'EMBASSY OF ERITREA'. We do not accept cash payment.

- All fees are non-refundable
- Applications must be signed by the Applicant or Parent/Legal Guardian in case of minors and children under 17 years old.
- Minimum of 10 days are required for processing
- Applicants sending application by mail must provide self-addressed return envelope with tracking number (Express Mail, Priority Mail, FedEx or UPS)

- Passport be valid at least six months beyond the dates of your trip
- Diplomatic note or note verbale stating purpose and duration of your stay
- Gratis (No Fee)

- Minimum of 10 days are required for processing
- Applicants sending application by mail must provide self-addressed return envelope with tracking number (Express Mail, Priority Mail, FedEx, UPS or DHL)

- Fee \$50 USD

- Proof of residency or Permanent Resident Card – for non-US citizens
- Passport be valid at least six months beyond the dates of your trip
- Air ticket itinerary and proof of visa for final destination
- Fee \$30 USD
- Money Order, Company and Cashier's Checks payable to 'EMBASSY OF ERITREA'. Cash payments are not acceptable.
- All fees are non-refundable
- Minimum of 10 days are required for processing
- Applicants sending application by mail must provide self-addressed return envelope with tracking number (Express Mail, Priority Mail, FedEx, UPS & DHL)
